**Subject: Regarding giving priority to allotment of plots in the area of Maharashtra Industrial Development Corporation to Micro, Small Enterprise-Industrial Group (MSE-CDP).**

Government Resolution No. SME-2013 from Maharashtra Govt. 207 / Udyog-7, dated 25.02.2014, as per the provisions of the Industrial Policy of the State, "Maharashtra State Industrial Group Development Plan (MSICDP)" has been announced with a view to the development of small groups in the industrially undeveloped areas of the State. Similarly, in order to promote the micro and small enterprises which are major contributors in the industrial development of the State of Maharashtra and to make them more competitive by increasing the quality of their products such industrial development groups need to be encouraged, thus it is proposed to give priority in allotment of plots to industrial groups under Central Government Micro-Small Enterprise Industrial Group Development Scheme (MSECDP) and I.I.U.S. and State Government's Maharashtra State Industrial Group Development Plan (MSICDP) was introduced. This issue was discussed in the meeting of the Board of Directors and Resolution No. 5633 was passed in that regard. The following policy is being issued in pursuance of that resolution-

1. In the industrial area of Maharashtra Industrial Development Corporation, allotment of plots for industrial groups should be given priority under the Central Government's Micro-Small Enterprise Industrial Group Development Scheme (MSECDP) and I.I.U.S. and the State Government's Maharashtra State Industrial Group Development Scheme (MSICDP).
2. In the policy issued as per the Circular dated 19.12.2012 and 10.01.2014 issued by MIDC regarding allotment of priority plots, industrial development groups are being included.

3. The policy / provisions in the Circular dated 22.01.2013 is being implemented for the development of plots thus allotted.

As per the Circular dated 26.09.2016 of MIDC, facilities as well as the right to allot plots at concessional rates, as there is a plot allotment committee under the chairmanship of the Co-Chief Executive Officer, such proposals should be submitted to the Plot Allotment Committee immediately.

This Circular is being issued with the approval of Hon'ble Chief Executive Officer, MIDC.
