CIRCULAR

Subject: Regarding powers of granting additional FSI as per CDCPR-2023 for various land uses permissible on plots in MIDC.

Vide Government Notification No. TPB-4322/314/CR-25/2022/UD-11 dt. 05/07/2023, the Comprehensive Development Control and Promotion Regulations-2023 for MIDC have been sanctioned by the Government in UDD and the same have come in force from 13/07/2023. As per clause no. 5.5 of the said CDCPRs, MIDC is empowered to approve basic FSI, FSI on payment of premium and ancillary FSI for the permissible land uses on MIDC plots and the Chief Executive Officer, MIDC exercises powers of Planning Authority as per section 152 of the MR & TP Act, 1966.

In this regard, it is observed that various circulars regarding powers of granting FSI over and above basic FSI, issued from time to time, are creating confusion and delay in the process of approval at various levels. Therefore, considering the type of work and number of cases, Chief Executive Officer, MIDC is hereby delegating his powers of granting in-principle approval to the FSI over and above basic FSI to the officers as mentioned in the table below.

It is further directed that -i) proposals of granting FSI over and above basic FSI in respect of IT / ITES / BT / NT / Data Center as per Table no. 5D, clause no. 6.1 and clause no. 6.6 of the CDCPR-2023 shall be submitted to the CEO, MIDC and ii) proposals of granting FSI over and above basic FSI shall be submitted to the respective officers as mentioned in the above table through the Chief Planner & Chief Fire Officer (wherever applicable) for all industrial areas of MIDC.

It is also directed that circular no. MIDC/CP/A46565/2014 dt. 09/06/2014, circular no. MIDC/CP/A37010/2015 dt. 12/02/2015, circular no. MIDC/CP/A84481/2016 dt. 21/03/2016, circular no. MIDC/CP/C48526/2019 dt. 09/08/2019 and circular no. MIDC/CP/D98932/2022 dt. 02/12/2022 shall be treated as cancelled.

All concerned officers of MIDC are hereby directed to take a note of the same and necessary action shall be taken accordingly.
