<u>Subject:-</u> Regarding the necessary ancillary actions to be taken for the operationalization of the Regional Office, Mavim, Baramati.

Office Order:-

1) The operational areas of the Regional Office, MOUVIM, Pune-1, Regional Office, Pune-2, and Regional Office, MOUVIM, Baramati will be as follows:

2	Regional Office, Pune-2	In Pune district, the operational and proposed industrial areas in the talukas of Haveli, Velhe, Bhor, Mulshi, and Shirur, as well as land acquisition activities related to the industrial areas in these talukas.
3	Re <mark>gional O</mark> ffice, B <mark>a</mark> ramati	In Pune district, the operational and proposed industrial areas in the talukas of Baramati, Daund, Purandar, and Indapur, as well as land acquisition activities related to the industrial areas in these
		talukas.

In accordance with the Office Order dated 13/08/2024 issued by the Maha Mandal, from the date of this order The Regional Officer, Regional Office, MOUVIM, Pune-1 shall manage the operational and proposed industrial areas in the talukas of Pune city, Khed, Maval, Junnar, and Ambegaon in Pune district, as well as land acquisition activities related to the industrial areas in these talukas. The Regional Office, Pune-2 shall oversee the operational and proposed industrial areas in the talukas of Haveli, Velhe, Bhor, Mulshi, and Shirur in Pune district, as well as land acquisition activities related to the industrial areas in these talukas. The Regional Office, Baramati shall handle the operational and proposed industrial areas in the

- talukas of Baramati, Daund, Purandar, and Indapur in Pune district, as well as land acquisition activities related to the industrial areas in these talukas.
- 2) The Regional Office, Pune-1 and Regional Office, Pune-2 should transfer all the records and other types of documents related to the operational and proposed industrial areas in the talukas of Baramati, Daund, Purandar, and Indapur in Pune district to the Regional Officer, Regional Office, MOUVIM, Baramati.
- 3) The additional responsibilities of the Regional Officer, MOUVIM, Baramati at the newly established Regional Office, MOUVIM, Baramati are being assigned to the Regional Officer, MOUVIM, Pune-1 through this order until further notice. The Regional Officer assigned additional responsibilities should visit the Regional Office twice a week to oversee the office work. Additionally, the appointed officers/staff at the Regional Office, Baramati are instructed to be present at the headquarters of the Regional Office (Baramati) and start the office operations.
- 4) From the date of this order, all responsibility for ensuring that the Regional Office, Baramati operates at the headquarters location will lie with the Regional Officer assigned additional responsibilities as well as the Chief Engineer, Pune.
- 5) Instructions given regarding necessary ancillary actions as per the Office Order dated 13/08/2024 issued by the Maha Mandal will remain in effect.
