**Subject:** Extension of deadline for the appointment of Co-Developer for the development of allotted plots in the Information Technology Park.

Considering the decline in the information technology sector, global, industrial, and economic recessions, and in order to encourage the development of plots allocated to entrepreneurs in the Information Technology / Information Technology Enabled Services (IT/ITES) sector in the Special Economic Zone (SEZ) and to ensure the rapid development of these plots, the prescribed time period for appointing a Co-Developer, as per the above-mentioned circular No. 7, has ended. Taking into account the representations/proposals received from entrepreneurs in this sector regarding the appointment of a Co-Developer, the matter of extending the time for appointing a Co-Developer was presented at the 403rd meeting of the Board of Directors of the Corporation held on 08/10/2024. After a detailed discussion on the subject, Resolution No. 6893 was passed. In connection with this resolution, entrepreneurs in the Information Technology / Information Technology Enabled Services (IT/ITES) sector in the Special Economic Zone (SEZ) are being encouraged for plot development

In order to encourage and ensure the rapid development of the plots allocated to them, the Co-Developer applications will be evaluated based on quality. As per the conditions mentioned in the above-referenced circular dated 11/11/2009, and in accordance with the resolution No. 6893 passed in the 403rd meeting of the Board of Directors on 08/10/2024, the time period for the development of plots, as per the circular dated 09/02/2023, will be extended for two more years, from 01/04/2024 to 31/03/2026. Furthermore, the authority to approve the Co-Developer (Co-Developer) will remain with the Honourable Chief Executive Officer.
